

## AU Credit Card Priority Pass Usage Terms & Conditions

1. AU Credit Cardholders can avail Priority Pass Membership as per defined product features/offering
2. Please refer below table for eligible list of AU Credit Cards highlighting Priority Pass membership and complimentary access at participating International Lounges
  - AU Zenith & Zenith+ Primary and Add on Credit Cardholders can avail complimentary Priority Pass membership
  - AU Traverse, Vetta, ixigo AU & ABC Pro Primary Credit Cardholders only can avail complimentary Priority Pass membership.

Zenith	2 International lounge access per calendar quarter
Zenith+	4 International lounge access per calendar quarter
ixigo AU	1 International lounge access every year
ABC Pro	1 International lounge access every year
Traverse	2 International lounge access per calendar quarter

3. Priority Pass will be issued on customer's request for AU Vetta, ixigo AU & ABC Pro cardholders. For Traverse, Zenith & Zenith+ Cardholders, Priority Pass membership Card will be delivered along with the Credit Card welcome kit.
4. Priority Pass lounge usage charges of **\$35 + GST** will be applicable for both domestic and international Airport lounge access within India. For International lounge visits Priority Pass usage charge of **\$35+ taxes**, will be applicable after exceeding the complimentary visits, as may be applicable for a given card variant. Any visit, over and above the complimentary visits, will be billed to the cardholder and will reflect in his/her Credit Card statement.
5. The Priority Pass membership entitles cardholders to access to 1,000+ airport lounges outside India. To refer eligible list of airports lounges, click on <https://www.prioritypass.com/en/airport-lounges>.
6. The usage of the Priority Pass is linked to above AU Credit Cards only. If the issued AU Credit Card account is closed/cancelled/permanently blocked, the linked Priority Pass will also get closed, cancelled, or permanently blocked.
7. Priority Pass usage charges (as defined above) will be billed within 90 days from the date of visit into the Credit Card statement of Cardholder for the month of Lounge visit done.
8. The dollar conversion rate will be applicable as per the prevailing rate on billing date.
9. To use the participating Airport Lounge, customer's priority pass card must be validated by swiping at point of Lounge entry.
10. In the event of AU Cardholder cancelling or not renewing his/her AU Credit Card, the Priority Pass Membership ceases to exist for the Cardholder.
11. Lounge visits are subject to a per-person-per-visit charge. All such visits, including those by accompanying guests, shall be debited to the cardholder's Credit Card by AU Small Finance Bank as per the rates and terms notified above
12. All participating lounges are owned and operated by third party organizations. The Cardholder and accompanying guests must abide by the rules and policies of each participating lounge/club. Access may

be restricted due to space constraint, but this will be wholly at the discretion of each individual lounge operator. AU Small Finance Bank has no control over the facilities offered, the opening/closing times or the personnel employed by the lounges. All accompanying children (where permitted) will be subject to the full guest fee unless otherwise stated in the lounge listing.

13. In case of a visit dispute, customer is required to bring it to the notice of AU Small Finance Bank within 30 days of the fee levy date.
14. AU Small Finance Bank reserves the right at any time, without notice, to add/alter/change/ or vary any or all of these terms and conditions or to replace, entire or in part, this offers by another offer, whether similar to this offer or not, or to withdraw it altogether.
